Greetings IBEW Members,

I am writing this message to ask for your assistance in notifying all IBEW union members in Canada, that IBEW Local 2085 has declared the Headworks project at the North End Water Treatment Plant Project in Winnipeg (NEWPPC) a "HOT JOB".

Recently I was notified that the general contractor, Red River Solutions, has awarded this phase of the project to the Christian Labour Alliance of Canada(CLAC). They may have a difficult time finding manpower for this project locally and have already started to advertise nationally.

We as a Local need to protect our jurisdiction and our members. It is for this reason, any member found to be working on this job may be charged under Article 25 Section 1 (f) of the IBEW Constitution which states:

(f) Working for, or on the behalf of, any employer, employer supported organization, or other union, or against the representatives of any of the foregoing, whose position is adverse or detrimental to the IBEW.

We must enforce our obligation to the IBEW as stated when every member joins:

"I, the undersigned, in the presence of members of the International Brotherhood of Electrical Workers®, make application to join the I.B.E.W.®, and promise and agree to conform to and abide by the Constitution and laws of the I.B.E.W.® and its Local Unions. I will further the purposes for which the I.B.E.W.® is instituted. I will bear true allegiance to it and will not sacrifice its interest in any manner."

Thank you in advance for your assistance in this urgent matter.
